Re: Request for an Open Records Decision

Dear Mr. Attorney General Paxton:

On November 14, 2018, the city of Dallas ("city") submitted a request for an open records decision to you (Exhibit A) regarding a request from Lucas Smolcic Larson.

This office is responsible for representing the legal interests of the city. Our previous submission is incorporated into this submission, including Mr. Larson's request. We listed the exceptions under the Public Information Act, Chapter 552, Texas Government Code (the "Act") which might apply to the requested information in our previous correspondence. In this submission, we shall expand upon and explain the reasons we believe these exceptions apply to the requested information. In our opinion, some of the requested information is excepted from required public disclosure under Sections 552.104 of the Act. Under Section 552.301 of the Act, this office now seeks your determination about whether this information is exempt from disclosure.

Exhibit B consists of a representative sample of the requested information that we believe is excepted from disclosure under Section 552.104 of the Act. Exhibit B consists of draft contracts that have not been fully negotiated or executed. Section 552.104(a) of the Act allows a governmental body to withhold information related to competition and bidding that, if released, would give an advantage to a competitor or bidder. Your office has stated that a "governmental body may seek protection as a competitor in the marketplace under Section 552.104 and avail itself of the "competitive advantage" aspect of this exception if it can satisfy two criteria." Informal Letter Ruling No. OR2007-06125. The first prong of the test requires that the governmental body demonstrate that it has specific marketplace interests. The second prong of the test requires that the governmental body demonstrate a specific threat of actual or potential harm to its interest in a particular competitive situation. *Id*.

The city has a marketplace interest, as it competes with other entities to attract and encourage certain events (in this case the World Cup), which will generate revenue and business within the city. Such opportunities are highly competitive and in this instance, Dallas is in direct competition with other North American cities for the rights to host World Cup games. A major sporting event such as the World Cup would clearly generate a large amount of tourism to the host city, creating an economic boost. Consequently, Dallas has a strong marketplace interest in

protecting the information in Exhibit B. The contracts in Exhibit B contain proposed terms that are still being negotiated with FIFA, and the selection process is still ongoing.

Accordingly, there is a specific threat of potential harm to the city's interest if the information contained in Exhibit B is released to the public. The "test under section 552.104 is whether knowing another bidder's [or competitor's information] would be an advantage, not whether it would be a decisive advantage." Boeing Co. v. Paxton, 466 S.W.3d 841 (Tex. 2015). Release of a contract that has not yet been finalized could thwart not only the ongoing project and proposal, but also future projects and/or proposals used to draw events to the city, as competing cities would have an unintended, deeper level of insight into the inner workings of the terms, evaluation, and negotiation process that underpin a deal that is still ongoing and in its early stages. Pursuant to *Boeing*, section 552.104 is not limited to only ongoing competitive situations. but even to situations where the release of competitively sensitive information would give an advantage to a competitor after the contract has been fully executed. Boeing, 466 S.W.3d at 831, 839. As previously stated, these contracts are not fully executed; though the city has unilaterally signed the agreements, the host cities have not yet been selected and the selection process may continue for quite some time. Release of this information at this stage in the process would provide competitors with an unfair competitive advantage against the city by allowing competitors to use the city's proposed agreements in the preparation of their own, potentially resulting in a loss of this opportunity to the city. For these reasons, and the reasons stated above, we believe that the contracts in Exhibit B should be withheld from public disclosure under 552.104.

By electronic submission (Exhibit A) received by the City of Dallas ("city") on November 2, 2018 Lucas Smolcic Larson requested information pertaining to specified records.

The city is gathering the requested information and it is anticipated that some of the requested information will be exempt from mandatory disclosure under the Public Information Act, Chapter 552, Texas Government Code (the "Act"). Since we have not been able to review all the requested information, we would assert that certain information contained in Lucas Smolcic Larson's request may be protected from disclosure under Sections 552.101 through 552.154 of the Act. In particular, sections 552.101, 552.104, 552.107, 552.111, and 552.131. Under Section 552.301 of the Act, this office now seeks your determination about whether this information is exempt from disclosure.

Our comments stating the reasons why the Act excepts the requested information from disclosure, and copies of the requested information (or samples if voluminous), will be sent to your office by November 23, 2018 as required by Section 552.301(e) of the Act.
